Minutes of the Plenary Session of the International Committee on Taxonomy of Viruses (ICTV)

11:30 Monday 17 July 2017 Sands Grand Ballroom I-L, Marina Bay Sands Convention Centre, Singapore

Chair: Andrew Davison (President of the ICTV)

Attendance: Approximately 50 people including >30 members of the ICTV

The chairman welcomed people to the meeting and apologised for the late start, which had been caused by the overrunning of the previous session.

1. President's Report

The chairman outlined the organisation of the ICTV and summarised the activities that had taken place during the period 2014-2017. A substantial expansion of virus taxonomy had been achieved, and a Bioresources Grant from Wellcome Trust UK was funding several specific projects, including the transition of the ICTV Report to a freely available, open access, online publication (the 10th Report) available at the ICTV website. Report chapters and summaries published in the Journal of General Virology had been released regularly since January 2017. The chairman acknowledged the tremendous contribution of the many virologists who had participated in ICTV Study Groups and provided taxonomic proposals.

2. Data Secretary's Report

Elliot Lefkowitz explained the continuing development of the ICTV website and the resources available, including current and historical taxonomy, the 10th Report, and various other pieces of news and information. He reported that 13 chapters and summaries were now available for the 10th Report, and that more were being prepared.

3. Subcommittee Reports

Brief reports were presented on behalf of the six Subcommittees, each summarising the progress made during 2014-2017 and highlighting the issues that were being discussed.
